■授業のテーマ

The course aims at tracing the evolution in relations between two contiguous regions: Europe and the Middle East and North Africa (MENA) in the last hundred years. At the end of the First World War, two European powers (France and Britain) dominated the Middle East and North Africa (MENA) transforming the region into a system of separate states and facilitating the establishment of the State of Israel, before retreating in the face of nationalist movements, USA rising influence and superpowers rivalry and clientelism. With the end of the Cold War, in the 1990s and 2000s, the United States emerged as the hegemonic power in the region, while the newly created European Union (EU) turned old imperialist relationships into commercial ones. Geographic proximity, economic interdependence and migration flows compelled the EU to launch a series of initiatives designed to address new transnational security concerns through the deployment of 'soft power', briefly challenging USA 'hard power' approach toward the region's developments. EU member states devised a common foreign and security policy toward their neighbours in the South and East of the Mediterranean, including a coordinated position in the Israeli-Palestinian conflict, but such efforts fell short of turning the EU into a unified actor with decisive regional influence. When in 2011 popular uprisings erupted across the Arab world, the EU was itself in the midst of an economic crisis that forced a rethink in European policies toward the region and a reassertion of bilateralism. ■授業の到達目標

After a historical background, the course will concentrate on the post-Cold War period outlining EU regional initiatives, the role of the European Union in the quest for a resolution of the Arab-Israeli conflict; the European impasse with respect to the 2003 USA invasion of Iraq and, finally, Europe's role in the genesis of the so-called Arab Spring and ensuing conflicts.

The final exam will be based on the lectures and the readings, in the form of an oral examination.

Students will obtain introductory knowledge about:

- The history of European-Middle Eastern relations in the last hundred years
- Main European Union policies towards the MENA region
- Literature debate on the nature and efficacy of European foreign policy
