2015 UNCITRAL ASIA PACIFIC DAY PROGRAMME AT A GLANCE

The United Nations Commission on International Trade Law (UNCITRAL) was established by the United Nations General Assembly Resolution 2205 (XXI) of 17 December 1966, recognizing that disparities in national laws governing international trade created obstacles to the flow of trade, and it regarded the Commission as the vehicle by which the United Nations could play a more active role in reducing or removing these obstacles. In 2014, the first regional centre of UNCITRAL, UNCITRAL-RCAP, established the UNCITRAL Asia Pacific Day to celebrate this historical resolution annually. This year, seven reputable universities across the region will be joining the celebration and it will continue to evolve in the years ahead.
